Economic Census is a complete count of all economic units in the country.

The First Economic Census was conducted through-out the country, except Lakshadweep, during 1977 in collaboration with the Directorate of Economics & Statistics (DES) in the States/Union Territories (UT). The coverage was restricted to only nonagricultural establishments employing at least one hired worker on a fairly regular basis. Data on items such as description of activity, number of persons usually working, type of ownership, etc. were collected.

The Second Economic Census was conducted in 1980 along with the house-listing operations of 1981 Population Census. This was done with a view to economizing resources, manpower, time and money. The scope and coverage were enlarged. This time all establishments engaged in economic activities both agricultural and non-agricultural whether employing any hired worker or not - were covered, except those engaged in crop production and plantation. All States/UTs were covered with the sole exception of Assam, where Population Census, 1981 was not conducted.

The Third Economic Census was synchronized with the house listing operations of the Population Census 1991 on the same pattern as EC- 1980. The coverage was similar to that of EC-1980. All States/UTs except Jammu & Kashmir, where Population Census 1991 was not undertaken, were covered.

Fourth economic census was planned during 1996. But due to various reasons the scheme could be launched in 1998.

The Fifth Economic Census was conducted in 2005 covering all activities except crop production and plantation and covered the whole country

The overall responsibility for organisation and conduct of Economic Census rested with the CSO. The DESs of respective States and UTs were made responsible for conducting the field work and preparing the report concerning their States.

Overview

ABSTRACT

The main objective of Economic Census is to prepare a frame of all "establishments" engaged in various economic activities which serves as a basic input for conducting detailed surveys pertaining to

any specific activity of the economy.

To improve the utility of the data collected and to improve the quality of data generated new initiatives were introduced permitting to prepare directory of establishments employing 10 or more workers etc. ICR technology has been used for the first time in this data processing to avoid any possible error in transcription of the data

The results of EC-2005 "ALL INDIA REPORT" contains the all India figures on the number of enterprises and their employment, cross-classified according to their locations, major activity groups, type of the establishments, size-class of the employment, etc. The disaggregated data for States/UTs are also included in the report. Unit level data of Enterprise Schedule are been made available to the user.

SCOPE AND COVERAGE

The Fifth Economic Census was conducted in all the States/UTs. All economic activities (agricultural and non-agricultural), except those involved in crop production and plantation, related to production and/or distribution of goods and/or services other than for the sole purpose of own consumption were covered.

However, as were done in earlier censuses, the following activities were kept out of the purview of the Fifth Economic Census.

(i) Establishments of shelter-less and nomadic population, which keep on moving from place to place and camp either without shelter or with shelter

(ii) Establishments engaged in some activities like smuggling, gambling, beggary, prostitution, etc.

(iii) Domestic servants, whether they work in one household or in a number of households, drivers, etc. who undertake jobs for others on wages.

(iv) All wage-paid employees of casual nature.

(v) Household members engaged in household chores.

(vi) Persons doing different types of jobs depending on the availability of work e.g. loading, unloading, helping a mason, carpenter, doing earthwork for

contractor

(vii) Household members working for other households and earning some money which is insignificant.

(viii) Households in which none of the members is engaged in any gainful activity i.e. households depending on remittance, rent, interest, pension etc.

(ix) Owners of tube-wells, tractors, bullock carts, etc. who utilise their spare capacity to earn extra money, if the spare capacity utilisation is occasional and

not on regular basis.

The fieldwork of Fifth Economic Census started in April 2005 and was over by December 2005 except in Bihar and Andaman & Nicobar Islands. Because of elections in Bihar and Tsunami rehabilitation work in Andaman & Nicobar Islands, the fieldwork was completed by early March 2006. About four (4) lakh enumerators were deployed to collect information from about 42 million establishments. Establishments with fixed premises were covered at the place of their operation. On the other hand, economic activities that are carried out without any fixed premises or location were covered through households.

All types of establishments (both perennial and seasonal) were covered in the census. The reference period for data collection in respect of perennial establishment was the last calendar year (i.e. Jan-Dec.2004) and for seasonal establishments, it was last working season. For the establishments that have started operation recently, (i.e operated less than a year for perennial establishments and did not complete a season for seasonal establishments), the information as on the date of the census was collected. The work of the enumerators was supervised by high level officers.

A separate address slip was canvassed to collect data on the establishments employing 10 or more workers for compilation of a directory of larger establishments. Intelligence Character Recognition (ICR) Technology was adopted in collaboration with the Office of Registrar General of India and Bureau of Economics and Statistics of State/UTs to process the data to avoid any possible error in transcription of the data.

Intelligent Character Recognition (ICR) technology, which is also known as Automated Forms Processing, was used to process the EC-2005 data. Automated Forms Processing technology enables the user to process documents from their images or directly from paper and convert them to computer readable data.

The schedules of the Fifth EC were scanned/digitized at the fifteen regional Data Processing Centres of Registrar General of India (RGI). After running the edit programme, the error list files were handed over to the State Governments for corrections. The DES officials of the State Government corrected the error files in two/three cycles and then sent the data files to RGI Headquarters to give final touch before sending to Computer Centre, MOSPI. The data files were made further error free by applying auto corrections at the Computer Centre.

Other Processing

A series of tables were generated: (a) main tables and (b) special tables. The main tables were to provide State/UT-wise results in respect of principal characteristics of the establishments and employment therein classified by major activity groups, type of establishments, ownership type, social group of owner, size class of employment, power/fuel used, source of finance, etc., The special tables were to reflect major characteristics of data at all India level.

The enterprise will be classified as agricultural or non-agricultural depending on the nature of the activity of the enterprise. Agricultural enterprises are those engaged in any of the activities relating to livestock production, agricultural services, hunting, trapping and game propagation, forestry, logging and fishing. The activities pertaining to crop production and plantations will not be covered under this census. Non-agricultural enterprises are those, which are engaged in any of the activities pertaining to :

- (i) Mining and quarrying
- (ii) Manufacturing
- (iii) Electricity, gas and water supply
- (iv) Construction

(v) Wholesale and retail trade; Repair of motor vehicles,

motorcyclesand personal and household goods

- (vi) Hotels and restaurants
- (vii) Transport, storage and communication services
- (viii) Financial Intermediation
- (ix) Real Estate, Renting and business activities
- (x) Public Administration and defence; compulsory social security
- (xi) Education
- (xii) Health & social work
- (xiii) Community, social and personal service activities.

Activities relating to processing of primary produce of agriculture and allied activities to make processed saleable goods which are carried out fairly on a regular basis are to be treated as non-agricultural enterprises and not as agricultural enterprises.

If the enterprise is of agricultural type, code 1 will be entered.

If the enterprise is of nonagricultural type code 2 will be entered.

Government including PSUs (code 1)

All enterprises\offices owned or run by Central Government, State Government,. Public Sector Undertakings, Local Bodies (Zilaparshad, City Corporation and Municipal Authority, Block Panchayat Gram Sabhas etc.) are considered to be Government enterprises. Research institutions, Universities,Educational Boards which are autonomous but are getting grants from Central or State governments or local bodies will also be included in the category of 'Government'.

All enterprises which are not treated as Government enterprises will be treated as Private enterprises and classified into one of the following:

Private Non-profit Institutions (Code 2)

Institutions, which are financed and controlled by households, societies, charitable institutions etc e.g. a Dharamshala, a Trust or a Temple etc are treated as Non-profit Institutions (NPIs) serving households. Institutions, which are financed and controlled by commercial organizations, e.g. Federation of Indian Chamber of Commerce and Industries (FICCI), or other Associations, are treated as NPIs serving commercial organisations/business houses. Both the type of institutions mentioned above fall under the category of "Private Non-Profit Institutions".

Private unincorporated proprietary enterprises: (code 3)

Enterprises that are owned by individuals or group of individuals would be treated as private Unincorporated Proprietary Enterprises. Most of the private enterprise will come under this category.

Private unincorporated partnership enterprises (code 4)

Enterprises registered under Indian Partnership Act 1932 as a partnership 'Firm' would fall under this category of 'Private Unincorporated Partnership Enterprise'. It may be noted that enterprises run by more than one person but not registered under Indian Partnership Act 1932 would not be treated under this category but as Private Unincorporated Proprietary Enterprises.

Private Corporate Non financial Enterprise (Code 5)

Those Private Enterprises (Companies) registered under The Companies Act 1956 and are carrying out non-financial economic activities would fall under the category of 'Private Corporate Non-Financial Enterprises'.

Private Corporate Financial Enterprises (Code 6)

The Private Enterprises (Companies) registered under the Companies Act 1956 and are carrying our mainly financial services would be treated as Private Corporate Financial Enterprises

Private Co-operative Enterprises (Code 7)

Enterprises, which are registered under Cooperative Societies Act 1912 or under any other law in force in any state for the registration of cooperative societies would fall under the category of Private Cooperative Enterprises.

. Codes 1-8 are applicable to private enterprises, which are on sole proprietary basis or on partnership basis for the purpose of this column. Government, Public sector, Limited companies etc. are classified as 'other than private enterprises'. For such enterprises there social group or gender of the owner is not relevant. The ownership code for all such enterprises will be 9.

If the private enterprise is run on partnership basis and the partners have different social groups, then for giving code priority may be given in the order ST first, SC second, OBC third and others last i.e., if an enterprise is jointly operated by an ST female (code1) and Others female (code 4), then code 1 will be relevant. If an enterprise is jointly operated by an OBC female (code 3) and ST male (code 5), then code 5 will be relevant. It is to be noted here that assigning social group of owner i.e. ST, SC, OBC and others will be on the basis of the practice followed in the State for classifying Tribes, Castes and Communities.

In this column power/fuel used in carrying out the entrepreneurial activity is recorded , the details of which are given below: -

If electricity is used for the purpose of lighting or heating the premises only, it is not considered to be the source of power/fuel for the activity. On the other hand, if electricity is used as a source of cooking in a hotel or restaurant, then code 2 is entered. In the case of a X-Ray clinic which necessarily uses electricity, the code is 2.

An enterprise using manual labour is counted as enterprise not using power and code 1 is given for such units. Coconut shells, dry leaves etc. used as source of power for heating the iron for pressing cloth, making tea or coffee in teashops, roasting grams or nuts etc. are given code 6 for 'firewood'. Similarly, charcoal used as source of power for an activity is given code 3 meant for coal/soft coke. For enterprises using non-conventional energy like solar energy, windmill, water mills etc code 8 is recorded.

In case more than one type of power/fuel is used for carrying out the entrepreneurial activity the code will refer to the major source or on which more expenditure is incurred. If an enterprise is engaged in more than one activity that cannot be distinguished, the power/fuel used in such cases will pertain to the major activity recorded in column 5 of Schedule.
