SCHEDULE 29.3 : PARTICULARS OF MIGRATION AND OWNERSHIP OF LAND BY NON-TRIBALS IN TRIABAL AREAS

- 8.0.1 In order to measure the disparity between the tribal and non-tribal households in respect of certain key characteristics and also the extent of displacement of the tribal population from the tribal belts due in-migration of non-tribals, schedule 29.3 is designed to collect information form the non-tribal households residing in the tribal areas. Thus this schedule will be canvassed only in the rural sector in the villages of general and special samples falling under stratum type 1 (tribal concentrated stratum). The particulars to be collected through this schedule relate to in-migration, economic activity, assets and liabilities along with the details about the extent and manner of acquisition and disposal of land by the non-tribals.
- 8.0.2 Schedule 29.3 consists of the following blocks:

Block 1: identification of sample household

Block 2: particulars of field operations

Block 3: remarks by investigator

Block 4: remarks by supervisory officer (s)

Block 5: household characteristics

Block 6: demographic and migration particulars of household members

Block 7: usual and current week activity particulars

Block 8: particulars of land owned and possessed activity on the date of survey

Block 9: particulars of disposal of land during last 5 years

Block 10: inventory of assets owned on the date of survey.

Block 11: particulars of cash dues and grain & other commodity dues payable by the

household on the date of survey and transaction of loans during last 365 days.

8.1.1 <u>Block 1</u>: <u>Identification of sample household</u>: The block is same as block 1 of schedule 29.1. The entries in this block will be made in a similar manner as explained in para 6.1.1 to 6.1.4

except that item 4, i.e., household serial number for schedule 39.3. Will be copied from column (17) of block 9 of schedule 0.1.

- 8.2.1 <u>Block 2</u>: <u>Particulars of field operations</u>: This block is self-explanatory.
- 8.3.1 <u>Block 3</u>: <u>Remarks by investigator</u>: Any remark which is considered necessary for explaining any peculiarity in any characteristics of the household will be noted here.
- 8.4.1 <u>Block 4</u>: <u>Remarks by supervisory officer (s)</u>: Supervisory officers may note their views on any aspect relating to the household and the entries made by the investigator.
- 8.5.1 <u>Block 5</u>: <u>Household characteristics</u>: Information on some socio-economic characteristics of the sample household will be collected in this block, Items 1 to 9 of this block are same as items 1 to 3, 5, 7, 8, 12 to 14 respectively of block 5 of schedule 29.2. The procedures for filling up these items have been explained in para 7.5.2, 6.5.3 to 6.5.6 7.5.4, 7.5.5 and 7.5.8 to 7.5.10.
- 8.6.1 <u>Block 6</u>: <u>Demographic and migration particulars of household members</u>: This block consists of 14 columns. These columns correspond respectively to cols. (1) to (6), (9) and (13) to (19) of block 6 of schedule 29.1 The procedures for making entries under these columns are same as those laid down for block 6 of schedule 29.1 in paras 6.6.1 to 6.6.6, 6.6.9, 6.6.10 and 6.6.13 to 6.6.18.
- 8.7.1 <u>Block 7</u>: <u>Usual and current week activity particulars</u>: This block is similar to block 8 of schedule 29.1 The instructions for filling up of this block are same as those provided for block 8 of schedules 29.1 in paras 6.8.1 to 6.8.12.
- 8.8.1 <u>Block 8</u>: <u>Particulars of land owned and possessed on the date of survey</u>: This block is similar to block 8 of schedule 29.2 except that an additional item of information "period since leased in" will be collected in schedule 29.3 under column (18). The instructions for filling up columns (1) to (17) of this block are same as those provided for block 8 of schedule 29.2 in para 7.8.1 to c.8.18.
- 8.8.2 It is to be noted that code list for cols. (9)/col. (13)/col. (17) provided in schedule 29.3 is different form the one provided for recording the entries in the corresponding columns of block 8 of schedule 29.2. The above mentioned code list as provided in Sch. 29.3 is as follows:

8.8.3 <u>Column (18)</u>: <u>Period since leased in</u>: Period elapsed since the area has been taken on lease will be recorded in column (18) in completed years in this column.

- 8.9.1 <u>Block 9</u>: <u>Particulars of disposal of land during last 5 years</u>: This block is similar to columns (1) to (12) of block 9 of schedule 29.2 The procedures for making entries in this block are same as those explained in para 7.9.1 to 7.9.9.
- 8.9.2 It is to be noted that the codes to be entered in col. (7) (to whom disposed) of block 9 in schedule 29.3 are different from those prescribed for the corresponding columns of the same block of schedule 29.2. The codes relevant for this block are given below:

- 8.10.1 <u>Block 10</u>: <u>Inventory of assets owned on the date of survey</u>: This block is exactly same as block 16 of schedule 29.2 and, therefore, the entries in this block are to be made according to the instruction laid down in para 7.16.1 to 7.16.3.
- 8.11.1 Block 11: Particulars of cash dues and grain & other commodity dues payable by the household on the date of survey and transaction of loans during last 365 days: This block is exactly same as block 17 of schedule 29.2. The entries in this block are to be made following the procedures laid down in para 7.17.1 to 7.17.10.
